Investor disclosure

In the last three months, Institut IGH, d.d. signed new contracts totalling just over HRK 30,5 million

Zagreb, 11 December 2020 – In the period Sept 1 to Dec 11 2020, i.e. in the past three months, Institut IGH, d.d. signed 65 new contracts with a total value of slightly over **HRK 30,5 million**.

These are contracts related to all types of services provided by the Company in the Republic of Croatia and abroad. The highest value of an individual contract is HRK 5 million, signed with the Company Elektroprojekt d.d., and the Company has already disclosed this information to the investment community on October 14, 2020.

Among other significant contracts, we would like to point out:

1. Development of designs and other design documents for the construction and modernization of the second track on the railway section Križevci-Koprivnica – Croatian State Borderline, concluded with the company CENGIZ INSAAT SANAYI VE TICARET A.S., Zagreb Branch, value over HRK 3,6 million.
2. Development of amendments to the Location permit with the implementation of geodetic and geotechnical surveys, update of detailed design and obtaining of Building permits for the Vukovar Bypass, concluded with Hrvatske ceste value over HRK 3.6 million.
3. Supervision services on the Project “Improvement of the water utility infrastructure of the Našice agglomeration” concluded with Našički vodovod d.o.o., value over HRK 2.9 million.
4. Supervision services during reconstruction of traffic areas and tracks in the area of the Cargo Port - Rijeka Basin, concluded with Luka Rijeka d.d., value over HRK 2.6 million HRK.
